GENERAL REQUIREMENTS FOR THE EDUCATION BOARD

The Board typically meets once each quarter. All requests for courses to be approved for initial certification or to meet qualifier requirements must be presented in person to the Board. A vote as to whether the course will be accepted will not occur when the course is presented to the board, whether initially or otherwise, but will take place at the next scheduled Board meeting. This will allow the Board to review, research and possibly audit the class to ensure it meets the minimum standard for that endorsement.

GENERAL REQUIREMENTS FOR FIRM QUALIFIERS

- All Qualifiers must receive a training certificate of completion with a passing exam score from the list of approved qualifier courses listed under the endorsement for which he/she is applying. The approved qualifier courses are listed in this document on pages 4-6 and 9-11.

- All Qualifiers must take a Fire Marshal Administrative Rules Course within one year of being designated as a Qualifier. This course must also be taken once every three years.
- Some Qualifiers must take a Fire Marshal Plan Review Course and Life Safety NFPA 101 Course based on the endorsement for which they are qualifying. The Fire Marshal Plan Review and Life Safety NFPA 101 courses must be taken within one year from date of licensure. These courses are taught by the Fire Marshal office as a combined class. These additional courses must be taken once every three (3) years.
 1. Fire Marshal Plan Review/Life Safety NFPA 101 Course and either
 2. Life Safety NFPA 101 Course; or
 3. NTS Life Safety NFPA 101 Course; or
 4. Oklahoma State University Life Safety NFPA 101 Course; or
 5. ALOA Life Safety Code Course.
- Courses taken no more than three (3) years prior to this date will be accepted to fulfill this requirement. All certification courses or professional licenses must remain current and valid. Any additional requirements of the certifying party must be met.

GENERAL REQUIREMENTS AND INFORMATION FOR TECHNICIAN AND SPECIALISTS

An individual is not eligible to perform Life Safe and Property Protection work until he/she receives a valid license from the Office of State Fire Marshal (OSFM). In order to obtain an OSFM-issued license, the following general requirements and points of information must be adhered to:

1. Testing and Examination
 - a. All technical training and/or testing for licensing qualification must include an exam with a pass/fail result.
 - b. Approved certification courses offered online are accepted with the requirement that the examination be proctored by a third party not associated with the firm for which the students work.
 - c. Instructors are not permitted to administer examinations or grade such for students for which they teach.
2. Training Certificates
 - a. The training certificate must be from an approved course listed under the endorsement(s) for which the person is applying. The list is shown on page 13 of this document.
 - b. A copy of the training certificate(s) must accompany an application for an initial individual license.
 - c. Each request for an initial endorsement must have its own training certification documentation included with the application.
 - d. The Life Safety and Property Protection Education Board will only consider courses submitted for initial certification and continuing education. It will not review or consider an individual's work experience as an equivalent to the listed approved courses.

LIFE SAFETY QUALIFIER CERTIFICATION REQUIREMENTS (Note: On the prior accepted Guidelines (2018), the Technician Certifications were listed first.)

Life Safety Firms

A. CONVEYANCE DEVICE INSPECTORS

1. Qualified Elevator Inspectors (QEI) Certification by the National Association of Elevator Safety Authorities (NAESA); **or**
2. Qualified Elevator Inspectors Certification by the Qualified Elevator Inspectors Training Fund; **and**
3. Fire Marshal Administrative Rules Course

B. CONVEYANCE DEVICE MECHANICS

1. Certified Elevator Technician (CET) certificate by the National Association of Elevator Contractors; **or**
2. Certification by the National Elevator Industry Education Program (NEIEP); **or**
3. An attestation submitted in the form of a notarized affidavit that the person who seeks licensure has worked as a conveyance device mechanic, as defined in R.S. 40:1664.3, for not less than four (4) years and six thousand (6,000) hours, within the last five years, without immediate or direct supervision prior to application for licensure. Application for licensure must be submitted by the employing licensed conveyance device firm; **or**
4. An attestation submitted in the form of a notarized affidavit that the person who seeks licensure has worked as a conveyance device mechanic, as defined in R.S. 40:1664.3, for not less than two (2) years and three thousand (3,000) hours, within the last three years, without immediate or direct supervision prior to application for licensure and that the person has received a National Association of Elevator Contractors, Certified Elevator Technician (CET) course. Application for licensure must be submitted by the employing licensed conveyance device firm; **and**
5. Fire Marshal Administrative Rules Course

C. DOT HYDROSTATIC TESTING (Requires firm RIN issued by DOT) (*Minimum Technician certification requirements listed below)

1. Hydrostatic Equipment Manufacturer Certification Training; **or**
2. Department of Transportation (DOT) Recognized Hydrostatic Testing Course; **and**
3. Certified Training Company (Cylinder Requalification); **and**
4. Fire Marshal Administrative Rules Course

D. FIRE ALARM

This requirement does not apply to individuals who hold a NICET 3 or higher certification in Fire Alarm Systems or the ESA/NTS Certified Fire Alarm Design Certification (CFAD), nor to any individual who is currently or has been previously licensed; **or**

5. Fire Marshal Fire Alarm & Locking Plan Review and Life Safety Code Course

This requirement does not apply to individuals who hold a NICET 2 or higher certification in Fire Alarm Systems or the ESA/NTS Certified Fire Alarm Technician (CFAT) Certification, nor to any individual who is currently or has been previously licensed. This requirement does not apply to individuals who hold a NICET 2 or higher certification in Fire Alarm Systems or the ESA/NTS Certified Fire Alarm Technician (CFAT) Certification, nor to any individual who is currently or has been previously licensed. This requirement does not apply to individuals who hold NICET 3 or higher certification in Water-Based systems Layout, nor to any individual who is currently or has been previously licensed. Approved documentation of experience may be in the form of a notarized attestation by the firm owner(s) or principal(s); **and**
3. Fire Marshal Administrative Rules Course; **and**
4. Fire Marshal Fire Sprinkler & Suppression Plan Review and Life Safety Code Course

 - c. Qualified Apprentice Program (National Fire Sprinkler Association (NFSA); **or** Sprinkler Fitters Local 669).
3. NICET 2 Certification (or higher) in Inspection and Testing of Water Based Fire Protection Systems must be obtained by the second renewal date.

Approved documentation of experience may be in the form of a notarized attestation by the firm owner(s) or principal(s). (Note: Effective December 31, 2023, NICET ceased offering the certifications in this endorsement field.); **or**
2. ***Elite CEU Video Surveillance Course** and established, documented base of experience in CCTV systems and that the applicant must have a minimum of three (3) years documented experience within the last four (4) years, without immediate or direct supervision, prior to application for licensure. This requirement does not apply to individuals who hold a current NICET 2 or higher certification in Video Security Systems Designer or Technician (See note below), nor to any individual who is currently or has been previously licensed. Approved documentation of experience may be in the form of a notarized attestation by the firm owner(s) or principal(s). (Note: Effective December 31, 2023, NICET ceased offering the certifications in this endorsement field.); **or**

LIFE SAFETY AND PROPERTY PROTECTION CONTINUING EDUCATION REQUIREMENTS AND GUIDELINES

- Effective at the time of an individual’s annual renewal, each individual license holder must document that he/she has obtained at least eight (8) contact hours of continuing education within the one (1) year licensing period. Documentation will be in the form of a statement (provided on the license application) that the individual must sign affirming he/she has met the requirement.
- The employer will also be required to affirm the employee has met the requirements by affirming such on the employee’s renewal application (again provided on the application). Continuing education documentation is not required to be submitted with the application but must be kept on file in the employee’s personnel file. This supporting documentation shall be maintained to facilitate verification when a facility inspection is performed by the fire marshal’s office. All documentation must be dated within one year of the new renewal date.
- Those who do not meet this requirement will not be renewed and shall be prevented from working in the industry.

- Administrative penalties will be pursued against those found falsifying documentation.
- An employee may be granted contact hours for each time he attends any course or activity approved for continuing education. Training may be obtained in any state. It does not have to be received in Louisiana to be acceptable.
- The maintaining of an individual's NICET certification will meet the requirements set forth by the Education Board.
- Individuals must obtain at least 50% of their continuing education hours from categories number 1, 3, 4, 6 or 9 of the Approved Continuing Education Courses and Methods list.
- Instructors of continuing education courses shall receive contact hours for the classes they teach on an hour for hour basis. Instructors shall also receive one (1) hour of credit for each proctored exam they administer.

5. How is the exam administered (open book, proctored, on-line, etc.)?
6. What is the revision cycle of the exam?

C. Presenter should be able to discuss the qualifications of instructor, which shall include:

1. The number of years in industry as trainer
2. Formal education/Credentials as instructor
3. Industry specific training/Experience on subject matter

CONTINUING EDUCATION REQUEST GUIDELINES

A. Submittal shall include the following:

1. Completed application
2. Course syllabus
3. Contact hour credit
4. Course material
5. Cost of training and testing
6. Location of training and testing

Definitions

Meeting (CH Accredited) – A structured member meeting of an approved industry or endorsement related association.

Licensing Category – Life Safety or Property Protection.

Business Development – Training that promotes industry or endorsement related professionalism or ethical business practices (management and/or self development).

Contact Hour (CH) – One hour unit for any approved contact hour training or approved contact hour method. (may be incremental)

Endorsement Related Training – Training specific to a particular licensing sub-category. This type of training can only be obtained for those endorsements currently held by the license holder.

Counter Day – Industry related equipment displays and training offered by manufacturers or distributors in an informal setting at the distributors place of business.

Industry – Business activity regulated by RS 40:1664.1 et seq.

Regulatory Training – Training offered by a recognized government agency or government approved training organization.

Trade Show – Industry related event consisting of exhibits of manufacturer, distributor, or business operation offerings.

Elective Course – Optional training of a generalized nature, which is not endorsement specific.

Employer In House Training – Training taught by an employer, to his own employees, on both endorsements related or elective subjects.
